GL Update

The Executive Director of Conservation gave an update of General licences as detailed below:

- Northern Ireland consultation process due to come out Mid-August.
- Wales likely to publish a new licence between 14th–19th August, BASC are engaged in consultation; and we have put forward evidence on species and the damage that is caused. A BASC survey is currently underway and results will be issued by end of July. It is hopefully that this will have some influence.
- Scotland announced their consultation this week, which is open until the 9th October. It is a fairly straight forward consultation.
- England Estimated that the consultation will be end August/beginning September.

Council were advised that we are working with the Shoot Liaison Committee and have instructed Field Fisher to pull together a list of questions for a QC to advice on. For example, what is the minimum you have to put into a general licence, we are also asking around the habitat and 300 metres noise disturbance. We do expect to have some challenges.
