Account surcharges

Zonal surcharges

The UK is divided into three Zones.

Zone 1:	England, Wales and parts of Scotland, excl. Highlands & Islands
Zone 2:	Highlands & Islands of Scotland

Zone 3: Northern Ireland, Isle of Man & Isles of Scilly

- A surcharge applies to deliveries to Zones 2 and 3 in the UK.
- You can calculate your zonal surcharge by multiplying your agreed contract price by 120% (delivery to Zone 2) and by 165% (delivery to Zone 3, except express**48** to Northern Ireland which is 70%), subject to the following minimum surcharge.

- A surcharge of £16.00 or 125% (whichever is the greater) per consignment applies to express**48^{large}** and express**24^{large}** deliveries to Zones 2 and 3.

Customs charges and clearance fees

Import into UK

If a parcel is received from outside the United Kingdom and addressed to you, you will be required to pay all of the relevant import duty, excise duty and VAT, along with any storage charges, and Parcelforce Worldwide clearance fees.

Export to the EU (Delivered Taxes Paid)

Customers exporting to the EU using our Delivered Taxes Paid (DTP) service will be required to pay all of the relevant import duty, excise duty and VAT, along with any storage charges and clearance fees.

Export to the EU (Delivered Duties Unpaid)

Customers exporting to the EU using our Delivered Duties Unpaid (DDU) service will be required to inform their end recipient that they will be responsible for paying all of the relevant import duty, excise duty and VAT, along with any storage charges and clearance fees.

UK Pallets

Zonal surcharges apply to both the collection and delivery of pallets despatched from or to the areas shown below. Charges are calculated by multiplying your pallet rate by the following percentages:

- Northern Ireland, Isle of Man and the Isle of Wight: 150%.
- Scottish Highlands and Islands and the Isles of Scilly: 200%.
