It was agreed that the Chairman, when preparing the Agenda, would mark those items he considered confidential.

### Additional Agenda Item - Update on Avian Influenza

It was noted that publicity had been focussed on the recent outbreak in Turkey and that DEFRA continued to push their advice. BASC had made 3 press releases, pushed their campaign to urge members to 'buy British', and were in the process of holding 8 roadshows across the country targeted at gamekeeper members. It was reported that the roadshows were well attended with around 50 members each evening. It was noted that information was to be circulated to 1800 clubs and syndicates. The deadline for registering flocks of 50 or more birds, which applies to England, Wales and Scotland, was  $28^{th}$  February. In Northern Ireland, collections of 1 or more birds must be registered.

### **A5.1** Verbal Up-date on Redevelopment at Trochry

It was confirmed that the building is now practically finished and in the snagging stage prior to the issue of a practical completion certificate by the architect and the completion certificate from the local authority. It was expected that the car park and drainage work would be complete by Monday. It was reported that fundraising efforts continued with a recent donation of £4k being made, bringing the total funds raised to some £70k. It is hoped that the official opening will be in Spring. It was noted that photographs would be e-mailed to Council members.

### **A5.2** Verbal up-date on proposed Communications Centre

It was reported that the Planning Office had reviewed the plans prior to their submission for formal approval and that they were content with the proposal subject to comments from the Highways Agency, who had visited the site. It was hoped to make a formal submission before the end of the month with consent expected at the end of March. During this period production information would be drawn up, contractors would be identified and the tendering process would begin. It is then anticipated that groundwork will commence in 5 to 6 months. It was reported that fundraising efforts were now underway.

### B1 To receive a paper on Confidentiality of Council business

The Chairman stood down for this item and the debate was conducted by the Vice-Chairman.

Council considered a paper which proposed an addition to the Council section of the Role & Operations Paper advocating that Council meetings be conducted under the Chatham House Rule.

Following a lengthy debate:

It was resolved that except where Council has decided that a matter will be treated as confidential, Council meetings shall be conducted under the Chatham House rules.

One Council member voted against the resolution but agreed to abide by it whilst retaining the right to resign from Council at anytime if he felt that there was something so fundamental that he had to speak out.

### B2 To receive a paper on a review of the number of Council meetings

Council received a paper which reviewed the number of current Council meetings against the historical number. Following discussion: It was noted that the current format would remain until at least June 2006, with the new Council left to decide if change was required.

### B3 To receive a paper on the succession of Chairman

Council considered a paper outlining the workload and time commitment of the current Chairman and the impact of this in appointing a successor.

It was agreed that this is an important issue and there is a need to consider the desired role of Chairman in the future.

# B4 <u>To receive a paper on the provision of relevant papers to Council members</u> wishing to attend committee meetings as observers

It was agreed that candidates standing for this year's election would be invited to the February meeting of Council.

Council received a paper on BASC as a sporting agency and noted that work was underway with regard to the provision of an opportunities and benefits database together with an ideas forum. Further updates would be provided at future Council meetings.

Council received this paper and were in agreement that the proposals contained within it were worth further exploration.

It was agreed that paper's author would attend the next Country and Regional Directors operations meeting to discuss the ideas further and then to liaise with the Chief Executive, the Director of Operations and the Director of Communications in order to progress the idea.

The Minutes of the Game Shooting Advisory Committee were accepted as presented. Noted that the recommendations of the Game-Shooting Advisory Committee to be incorporated in the paper on the Future of Game Shooting.

### C1.5 Scottish Committee – 8.12.05

The Minutes of the Scottish Committee were accepted as presented.

### C2 To take the Chairman's Activities Report

The Chairman's Activities Report was accepted as presented.

### C3 To take the Chief Executive's Report

Council were taken through the minutes of a meeting held on the 16 January 2006, with the CLA, BASC, CA and GCT in attendance.

Council agreed to the principle of continuing discussions in relation to the future of the Shoot Summit meetings.

Council noted that a paper would be circulated to them regarding a meeting between HMRC, BASC and CLA and that a member's pack was being produced in relation to the VAT compliance by shoot businesses across the UK.

The Chief Executive provided a brief report on the shoot assurance scheme. He said that the CLA executive committee were to discuss the matter but there are still some issues to sort out with partners, and that when that had been done he would bring the matter back to council.

The Chief Executive's Report was accepted as presented.

### C.4. To take the Director of Communications' Report

An update regarding cage laying systems was provided to Council. It was noted that the Minister had given assurance that BASC's position would be included in the Code of Practice.

An update regarding the Animal Welfare Bill and specifically tail docking was provided to Council. The Communications team had sent briefing notes and photographs to MP's and were planning to lobby Parliament in February. It was noted that a postcard would be included in the next issue of Shooting and Conservation and that members would be encouraged to post these to their MP. It was noted that a discussion had been held with ACPO as they too would require an exemption for sniffer dogs and that they had been urged to make representations. It was also noted that the Animal Health and Welfare (Scotland) Bill still retained the provision allowing the docking of working and sniffer dogs.

The Director of Communications Report was accepted as presented.

### C.5. To take the Director of Business Management's Report

It was noted that changes may be introduced to the way VAT is charged and that this may be applied to membership subscriptions. Caution on spending was currently being exercised.

It was reported that the pattern to membership remained erratic and that the net effect of this on income was flat.

It was noted that a set of final figures would be provided to the February meeting of Council.

The Director of Business Management's Report was accepted as presented.

### C.6. To take the Director of Operation's Report

The Director of Operation's Report was accepted as presented.

### D.1 To take Any Other Business by Leave of the Chairman

Council were reminded of the need to ensure that their requirements for overnight accommodation before the AGM were communicated to the IPS Secretary before 31 January 2006, as a room could not be guaranteed after that date.

The Chairman of FAWAC reminded Council that it had previously ruled that he was to be kept informed whenever BASC was to support a member in a court case. The Director of Operations report mentioned two instances of support for members that hadn't been advised to the Chairman of FAWAC, contary to the agreement. It was confirmed that the agreed procedure must be followed.
