B3. To receive a review of the effectiveness of the special membership category for student gamekeepers.

The Director of Business Management provided Council with an oral report on the effectiveness of the special membership category for student gamekeepers.

B.4 To receive a presentation 'wildfowling mapping project' by the Wildfowling Officer

Mark Greenhough gave a presentation to Council on the progress being made in updating the maps of land under the control and tenure of BASC affiliated wildfowling clubs in the United Kingdom.

Council noted that maps have been completed for 130 of the possible 154 affiliated wildfowling clubs in the UK and congratulated the Wildfowling Team on the excellent work undertaken to date on this project.

B.5 To decide the Budget for 2011 and confirm subscription rates, incorporating recommendations regarding the introduction of a phased payment option.

D.1. To take Any Other Business by leave of the Chairman

- (1) Noting the concerns expressed during the budget debate regarding the Association's dependency on membership subscriptions and also the retention benefits to be derived from membership contact, Council members were urged to consider alternative opportunities for raising funds.
- (2) It was noted that Promatic have extended their operations to include airgun targets and are keen to work with BASC on the promotion of the system for young people.
- (3) The Chief Executive informed Council that four affiliated Clubs on the Dyfi are currently involved in a dispute with the RSPB relating to the registration of land over which they shoot and may seek BASC's financial support of their legal costs. The Chief Executive stated that BASC is not a legal aid body but every case is to be judged on its merits. He had asked the Director Wales to provide him with details of the clubs' anticipated costs, the clubs' available funds and the efforts they are taking to raise funds. One solution would be for BASC to offer the clubs a loan and he sought the Council's support, which was given.
